## Minutes of the Regular LMC Meeting of January 26, 2023

## **AHEMS Updates**

#### Finances

The net operating income for November 2022 was \$90,000 which was \$136,000 ahead of plan. Year-to-date Net Operating income is at \$11,810,000 which was \$2,049,000 ahead of plan. Net revenue was \$427,000 ahead of plan, salary expenses were \$307,000 behind plan and non-salary expenses were \$99,000 behind plan. Billed transports were ahead of plan by 451. Gross charges were ahead of plan by \$1,416,000, salaries and benefits were behind plan by \$192,000, utilities and maintenance were behind plan by \$112,000 and bad debt was behind by \$124,000.

\*\*Every year AHEMS creates a budget to guide operations and provide expectations for recapitalization of the organization. When you hear us use the term "behind plan" this refers to the fact we are performing at a rate that will leave us short of our established goal. This does not mean we are losing money; we're just not making the amount we targeted before January 1st. Likewise, the term "ahead of plan" refers to the fact we are doing even better than was predicted which is a wonderful situation!\*\*
